## QUICK FACTS

The Midway ISD Board of Trustees unanimously called a bond election for \$34,493,201 that will be held on May 11, 2013. The school tax rate will not increase if the bond election is approved by voters.

The bond package, developed by a community advisory committee consisting of parents, local citizens, business leaders and school staff, will affect every student in the district and includes district-wide technology upgrades for students and teachers, new and renovated fine arts and extracurricular facilities and equipment, facility maintenance projects and new buses.

### WHAT'S PROPOSED?

#### TECHNOLOGY

New security cameras  
Mobile technology devices for every student ("1:1 Initiative")  
New and upgraded technology infrastructure and data storage

**ESTIMATED TOTAL: \$10,383,789**

#### FINE ARTS & EXTRACURRICULAR ACTIVITIES

Classroom additions for MHS Fine Arts programs (Theatre, Orchestra, Choir, Dance, Band)  
Renovations to Performing Arts Center and MHS Theatre  
New multi-purpose Student Activities Facility  
New equipment for band, music, choir, art, orchestra and dance/drill team

**ESTIMATED TOTAL: \$16,600,605**

#### MAINTENANCE

Repairs and renovations to HVAC systems, roofing, windows, doors, flooring, MMS canopy and other general renovations

**ESTIMATED TOTAL: \$4,494,807**

#### TRANSPORTATION

New buses (regular route, special needs, trip) and two district-wide vehicles

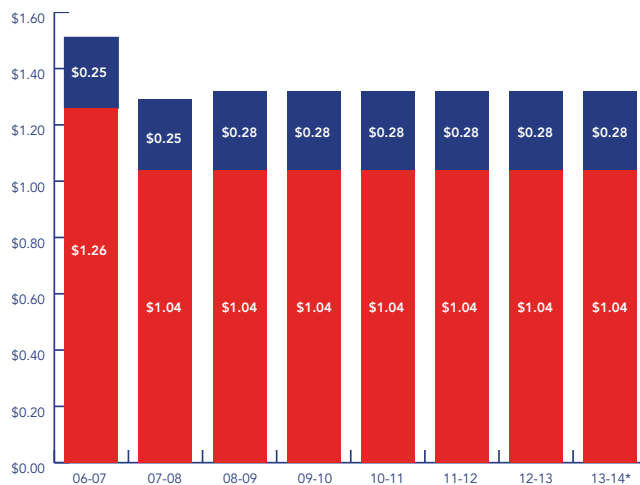
**ESTIMATED TOTAL: \$3,014,000**

**TOTAL BOND PACKAGE: \$34,493,201**

### DOES THIS AFFECT THE TAX RATE?

If the bond election is approved by voters, the school tax rate will not increase.

How is this possible?  
Increasing property values due to housing growth and business development have increased the amount of revenue the district collects. These increased revenues will allow new debt to be issued without raising the tax rate.
